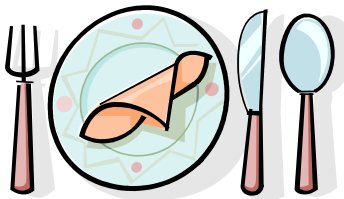
Next Meeting April 3, 2009 1:00 – 3:00
